1. INTRODUCTION

The present Regulation for the use of the IQNet logo, comprises a set of guidelines which every customer that is awarded an IQNet Management System Certificate must comply with, before and after the administration of an equivalent certificate by the Cyprus Certification Company.

2. LEGAL FRAME

The Board of Ministers on the 8th of August 2001 and with decision number 54.094 founded the Cyprus Certification Company Ltd (CCC) that is managed by a Board of Directors

The aim of founding CCC is the provision of services in the field of certification, as determined in the relevant documents.

CCC operates in the field of Certification of Management Systems (according to e.g. ISO standards) and it complies to its documented procedures and regulations.

CCC is a partner of the international network of certification bodies IQNet (IQNet Franchising Body, IQNet partner).

The International Quality Network (IQNet), has been operating since 1990, with 36 certification organizations as partners and more than 200 members worldwide. The aim of IQNet is to recognize and promote certificates issued by its members.

Within the framework of this present Regulation and all other relevant procedures, CCC issues Certificates of Conformity and awards respective Logos that indicate conformity of products, processes, procedures, organizations, systems, individuals and/or any combination of the previously mentions, according to the requirements of standards. In parallel, IQNet issues corresponding certificates to all CCC customers in the field of Management Systems.

3. USE OF THE IQNet LOGO

The IQNET recognized certification mark is owned by the IQNET Association.

Businesses by IQNET members against endorsed products and services may proudly carry the IQNET mark. As globally recognized brand, together with the CCC original mark, the IQNET mark pushes certified organizations' business at par with international players, opening for you more opportunities to trade, build international presence, and sustain growth.

The IQNET recognized certification mark shall be used in combination with the certification mark of CCC and may only be used by the certified organisation according to the following rules:

- Always in conjunction with CCC own certification mark
- clearly linked to the name of the certified organization
- within the validity period of the CCC and IQNET certificate
- within the certified scope/area
- without any changes
- enlarging or reducing is allowed. Its size can be reduced as long as the wording is clearly readable.

The IQNET recognized certification mark may be used*:

- In documents, signs, windows, website, advertising media; when the certificate coverage/scope does not cover all activities of the organization and when its use may induce in error on the certified scope, a clear description of the certificate coverage/scope shall be made together with the IQNET mark
- On "secondary packaging" like boxes etc. used for the transportation of products (which can reasonably be considered as not reaching the end user).

The IQNET recognized certification mark may not be used*:

- On products nor on "primary packaging" or any "secondary packaging" which could reach the end user (e.g. a tray containing cartons of milk, a box containing multiple packs of 500 sheets photocopy paper etc.).
- Shall not be used related to any kind of management system certification when forbidden by legal requirements.

The IQNET recognized certification mark colour:

The IQNET recognized certification mark should be applied in IQNET Blue, or in white when on IQNET Blue background, whenever possible. The IQNET Blue specific colour types and their values are as follows:

- for blue colour: "PANTONE" 661
- for four colour printing: C100, M80, Y0 K0
- for web: R0, G53, B148



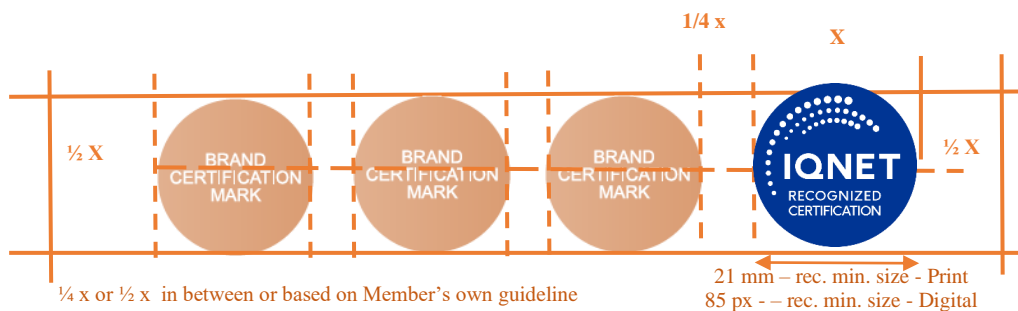
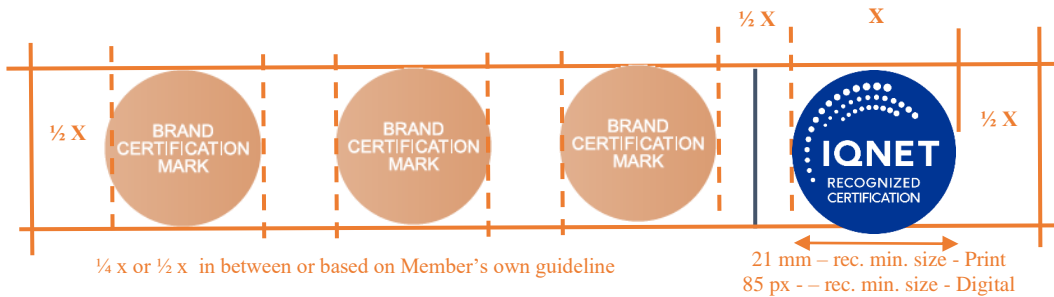
In exceptional cases where it is not possible for the IQNET recognized certification mark to be applied in IQNET Blue, it may be applied in black & white.

Artworks of the IQNET recognized certification mark is provided by CCC together in this package.

The IQNET recognized certification mark together with CCC certification mark.

IQNET recognized certification mark shall always be paired with CCC certification mark. The width of IQNET mark should be used as a guide for the size and spacing for both marks.
